Imagine coloring a page and creating a design that would be featured on 90,000 mugs and sold at Cedar Fair parks across the US and Canada. This is now a reality for nine-year-old Megan Thompson from our A Kid Again Central Carolinas chapter!

Thanks to our amazing partnership with Cedar Fair, a contest was launched within the Central Carolinas chapter that allowed A Kid Again families to design the artwork for the 2022 Winterfest souvenir mug. Twenty-two entries were submitted and Megan's was chosen as the winner.

Megan is the sibling of an enrolled child and often misses out on quality time with her family so the win was extra exciting. She even got to light the tree at Winterfest to celebrate and kick off the holiday season!

While planning an Adventure In A Box, A Kid Again aims to bring to life imagination, creativity and play. Creating memories for our kids and their families from the moment the package arrives at their doorstep is important to our mission!

With the support of many Adventure Guide “Box Builders,” A Kid Again was able to present a custom LEGO kit to enrolled families across the U.S. The custom A Kid Again LEGO roller coaster design represented the FUN our families have while at the Cedar Fair parks.

Families also received a video tutorial and experienced a Q&A with the LEGO Master Builder where he answered questions like what his favorite builds were and how he organized his LEGOS.

And because the LEGO box was so family inclusive, it was incredibly impactful for enrolled kids with older siblings who weren't expecting to be included because they weren't the medically fragile child.

Colts & Browns created unique Adventure opportunities for A Kid Again Families

The Cleveland Browns and Indianapolis Colts created unique opportunities for A Kid Again families in Northern Ohio and Indiana.

As a part of CrucialCatch, the Indianapolis Colts joined with our A Kid Again Indiana chapter and Ashley HomeStore to host the Colts Heroes Fashion Show, supporting A Kid Again.

Colts players, cheerleaders, and team mascot “Blue” were all on hand in costumes to walk the runway alongside more than 20 costumed kids. A Kid Again mom, Erin Scott, shared that her daughter’s experience was something she’d never forget.

Families had the opportunity to watch the Cleveland Browns prepare for their upcoming season, while enjoying music and games. After camp was over, families were able to capture photos and autographs with Joel, his teammates and head coach, Kevin Stefanski.

Joel also wore specially designed cleats representing A Kid Again as part of the NFL’s My Cause My Cleats program that were later auctioned, and the proceeds were donated to the A Kid Again Northern Ohio chapter.





Franklin County Public Health helped A Kid Again expand

Our Central Ohio chapter was awarded a **\$1 MILLION GRANT** through the American Rescue Plan funds to spread the reach of the services A Kid Again offers. Through this partnership, the frequency, quality and availability of Adventures increased.

The grant also ensures A Kid Again can serve every family eligible regardless of race, gender, ethnicity and financial status by allowing A Kid Again to focus on getting information into under-served communities, including immigrant and refugee communities. Services and information have been translated into several languages including Spanish, Bhutanese and Ukrainian to help reach ALL families.

"At that moment my (typical) daughter was trying to assist her brother up the slide for his first time. Thanks again for another amazing event!"

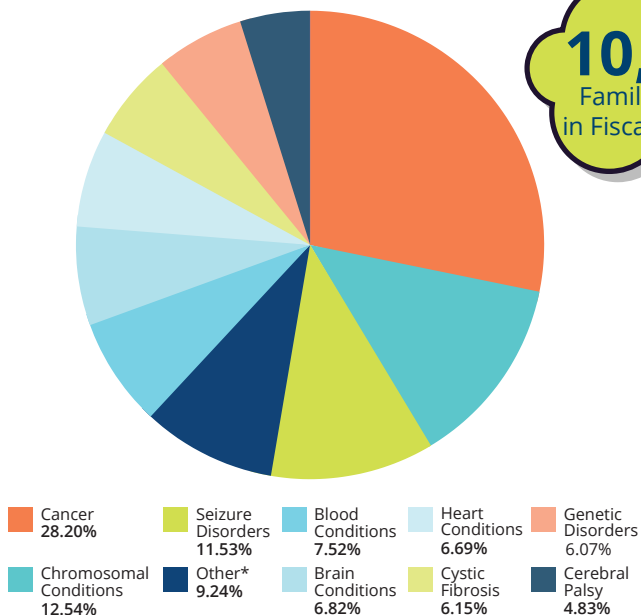

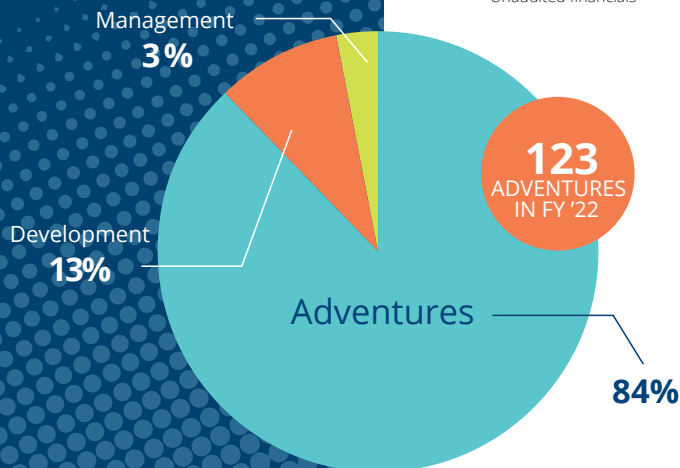
